## 4. SUPPORTING DOCUMENTATION

- 4.1 Tronos Aviation Consulting Inc. must submit, no more than once a month, a claim for payment using form PWGSC-TPSGC 1111, Claim for Progress Payment or Lockheed Martin invoice. Subject to the Basis of Payment, payment will only be made on receipt of a completed progress claim duly supported by specified release documents and other documents called for under the Contract.
- 4.2 Each progress claim must show:
- a. all information required on form PWGSC-TPSGC 1111; and
- b. a list of all expenses for that specific period, i.e. the total labour hours per category, the current rates and markups per category, detailed travel and living expenses and any other related costs.
- 4.3 Each progress claim must be supported by detailed report of the work performed for that specific period by BOE# to show actual LOE against authorized planned LOE;
- 4.4 A copy of all receipts and vouchers for all direct travel and living expenses related to this task, shall be provided upon Lockheed Martin's request.
- 4.5 Tronos Aviation Consulting Inc. must prepare and certify one original in blue ink and two (2) copies of the claim on form PWGSC-TPSGC 1111 or Lockheed Martin invoice and forward it to the Lockheed Martin Designated Authority.

### 5. **PERIOD OF PURCHASE ORDER**

5.1 The period of this Purchase Order shall be from 1 May 2017 to 1 September 2017 (with two optional 30-day periods available if needed, but not to exceed 180 days).
